<Optional Review Process>

- Deadline for CN submission by Economy Representative or Project Overseer (PO) : 02 October 2019
- CNs submitted to APEC Secretariat by EG/TF Secretariat: 09 October 2019
- At the EWG58 meeting (16-17 October), proposing member economies will be able to make a brief presentation on your draft CN and seek feedback and co-sponsorship from members if they wish.

Key Information

- Project Session 1 (2020) **dates and funding availability** will be advised following ISOM 2019. Please monitor the APEC website or contact your Program Director.
- Please **submit your Concept Note as early as possible**. Try to submit the year before your events are planned, even if events are planned for SOM3. The earlier your invitations and nomination requests are issued the stronger the attendance at your events.
- When completing the Concept Note **a good tip is to prepare your answers (in advance)** to the questions on *Outputs*, *Outcomes* and *Monitoring & Evaluation* in the Project Proposal. This will strengthen the presentation of your concept and help to expedite the transition from Concept Note to Project Proposal, if you are approved.
- Please **express your project objective in a single sentence of 100 words** (and avoid simply listing the activities and outputs of your planned project).
- **Use the resources in the PO Toolkit** when preparing Concept Notes and Project Proposals (<https://www.apec.org/Projects/Forms-and-Resources>)



PROJECT UPDATES

Key Information

- Self-funded Projects **must comply with APEC guidelines and practices** (hosting, publications, logo use, non-member participation)
- Project Overseer must submit **Self-Funded Project Proposal Coversheet** (Guidebook on APEC Projects, Appendix C) to the Secretariat before commencement of the project
- Project Overseer is strongly encouraged to submit **Completion Report** (Guidebook on APEC Projects, Appendix G)
- **Monitoring Reports (MRs)** are due on 1 February and 1 August for projects selected in 2017 and earlier. 2018 and 2019 projects are due once-yearly on the date advised to POs in the Letter of Acceptance (either 1 April or 1 October).
- **Completion Reports (CRs)** are due within 2 months of the end of a project.
- Penalties apply for late submission of MRs and CRs.



KEY ADVICE FOR PROJECT IMPLEMENTATION

How to have a successful workshop:

- Give at least sufficient notice to members of workshops, nomination requests.
- Do your research and use your networks to find the right participants and speakers (don't rely on members to find them for you).
- Involve relevant International Experts and organizations as speakers, ensuring you follow the Guidelines on Managing Cooperation With Non-members.
- Invite a representative(s) of other APEC working groups if relevant.
- Work closely with your Secretariat Program Executive on travelers approvals and acquittals.



KEY ADVICE FOR PROJECT IMPLEMENTATION

Be familiar with and follow APEC procurement rules:

- *Guidebook* Chapter 12 on Contracting
- Procurement takes time! Refer to your Letter of Acceptance for suggested timelines.
- Different requirements for contracts below USD 5,000; 20,000; 50,000; 50,001 and above.
- When evaluating bids, ensure that the specified Evaluation Criteria identified in the Request For Proposal (RFP) documentation are used to evaluate the bids.
- For over USD 50,001 get your proposal assessment panel together early. Only members of your forum officials (or their nominated delegates) can be assessors.
- Use the RFP timeline and correct templates

2019 APEC GENDER FOCAL POINT REPORT

- One of the ways the APEC Secretariat supports the mainstreaming of gender issues in APEC is through the Secretariat's annual Gender Focal Point Report (GFP Report)
- Aim of GFP Report is to update PPWE members on how well APEC projects are (or are not) addressing gender issues
- This year, PPWE requested that the GFP Report be shared with all APEC working groups, since it has findings relevant across APEC

2019: An Increased Focus on Gender Issues

- With Chile setting “Women, SMEs and Inclusive Growth” as a priority for 2019, there has been an increased, and welcome, focus on gender issues throughout APEC
- A number of new gender focused projects initiated by a wide range of APEC fora – for example, ATCWG has launched new project focused on women and corruption. First time this group has focused on gender issues.



GFP Report: target setting

- In quality assessment of APEC projects, Secretariat encourages all POs to set targets of at least 30% (but not more than 50%) for number of women speakers and participants involved in their APEC funded project events
- Secretariat tracked gender targets set in APEC projects initiated in 2018 and found:
 - More than half of APEC projects initiated in 2018 have targets of 30%+ for female speakers and participants
 - But, only 12% have balanced speaker and participant targets (i.e. 50%)
- **PPFS and HRDWG** stand out groups in this area: majority of PPFS and HRDWG project proposals from last project round include target of between 40% and 50% for female speakers and participants.
- Secretariat now collects data on whether targets are being met. Will provide performance data for all APEC groups in next GFP Report.



GFP Report: female representation at APEC project events

- Female representation in APEC-funded project events in 2018:
 - **44% of participants were female**
 - **32% of experts and speakers were female**
- Looking at ways to increase these figures, particularly for experts and speakers

GFP Report: Notable work and outcomes

- Excluding PPWE, following are the groups with highest average female participation rates: **CTI, EC, HWG and SCSC**
- Two projects that stand out:
 - **EWG 10 2017A** on “Electromobility: Infrastructure and Workforce Development” led by Chile
 - **TWG 01 2016A** on “Volun-Tourism Best Practices: Promoting Inclusive Community- Based Sustainable Tourism Initiatives” led by PNG
- Both of these projects, while not primarily focused on gender issues, took a proactive approach to addressing relevant gender issues in their project design
